Exhibitor Agreement

Conditions

The Pediatric Orthopaedic Practitioners Society (POPS) agrees to provide exhibit space for the above-listed exhibitor for the course presented on the date and location designated above. POPS will acknowledge exhibitor support in course materials.

The exhibitor acknowledges that conducting marketing or promotional activities in any conference area except for their assigned exhibit space is prohibited. Commercial interests may not engage in sales, promotional activities, or distribute product-specific advertisements while in the designated location of the CME activity. CME activity space includes, but is not limited to, lecture halls, break out rooms, and laboratory areas.

Exhibitors and POPS agree to abide by the ACCME Standards for Commercial Support of Continuing Medical Education. Any actions that are not in accordance with the above stated policies may result in the removal of the exhibit company and its representatives from the conference site, in which case no refund of exhibit fees will be allowed.

Arrangements for commercial exhibits or advertisements cannot influence planning or interfere with the presentation, nor can they be a condition of the provision of commercial support for CME activities.

Exhibit fees shall be set by faculty/planners for each activity. Potential exhibitors shall have equal access to purchasing exhibit space (first come-first serve).

All exhibitors must be in a room or area separate from the educational activity and the exhibits must not interfere or in any way compete with the learning experience prior to, during, or immediately after the CME activity.

Commercial interest representatives may attend CME activities at the discretion of POPS for the direct purpose of the representatives' own education; however, they may not engage in sales or marketing activities while in the space or place of the educational activity.

Any actions that are not in accordance with the above stated policies may result in the removal of the exhibit company and its representatives from the CME activity site, in which case no refund of exhibit fees will be allowed.
